By paying your registration fee and accepting a guaranteed charity entry, you agree to the following terms and conditions:

Registration Fee

- I agree to pay a non-refundable registration fee of £10.00
- I understand that my place is not guaranteed until this fee has cleared
- I will inform Little Hearts Matter immediately if I am unable to take part in the event. All monies paid to Little Hearts Matter to this point are non-refundable and treated as a donation

Donations & Payment Terms

- I pledge to raise a minimum of £50 to be shared between Little Hearts Matter and The Rotary Club of Wolverhampton though my participation in the event
- I will share the Team fundraising page <u>https://donate.giveasyoulive.com/fundraising/little-hearts-matter</u> with my offline and online network to raise funds.
- I will use a sponsorship form to collect details of my offline sponsors and any possible Gift Aid declarations and send these to Little Heart Matters following the event
- I understand that all sponsorship monies must be paid to Little Hearts Matter within 30 days of the Event taking place
- I will, if the sum of £50 has not been paid within one month of the event date, pay the remainder from my own personal funds within one month of this date or in instalments to be agreed with Little Hearts Matter in writing

Fundraising
